Section II must be completed and documentation attached only if the event needs to occur **before 3:30 pm on a school day**. You must complete Sections I & III for ALL EVENTS. **Events backing up into the school day on Friday must use 8 hours on Saturday first**, then back up the schedule from 9:00 pm on Friday evening. Documentation must accompany the request.

NOTICE THE JUNE 5, 2024 DEADLINE. I will forward the forms to AAA.

ALL INVITATIONAL events **require** the AAA-ASBOA Invitational Sanction form.

Arkansas students may not compete before 3:30 pm on a school day. Please make this clear to your out-of-state hosts before you ask for sanction.

REGION CHAIRMEN, PLEASE take care of the necessary ballots and forms **BEFORE** June 5, 2024. I must receive the approved sanction form before your dates can officially be added to the calendar. If a date you turn in is different than the one assigned, I am assuming you have followed the correct balloting procedures. You will retain the ballots with your records.
